

Press Note

Mumbai, 30 October 2019: On October 24, 2019, the Hon'ble National Company Law Appellate Tribunal ("**NCLAT**") set aside the order passed by the Hon'ble National Company Law Tribunal, ("**NCLT**"), Mumbai. The NCLT, by its order of January 21, 2019 (made available on February 12, 2019) ("**NCLT Order**"), had dismissed the proposed scheme of arrangement and amalgamation between UFO Moviez India Limited ("**UFO**"), PJSA Technosoft Pvt. Ltd. ("**PJSA**"), Qube Cinema Technologies Pvt. Ltd., Qube Digital Cinema Pvt. Ltd., Moviebuff Pvt. Ltd and their respective shareholders and creditors (under Sections 230-232 and other relevant provisions of the Companies Act, 2013) ("**Scheme**"), based *inter alia* on objections of the Regional Director, Ministry of Corporate Affairs, Western Region ("**RD**").

In February 2019, UFO and PJSA approached the NCLAT by way of an appeal against the NCLT Order ("Appeal").

The NCLAT, in its Order dated October 24, 2019 has allowed the Appeal and has set aside the NCLT Order, including the adverse remarks passed against UFO and PJSA therein. Further, the NCLAT, in its order, records that the representative of the RD has conceded before the NCLAT that the grounds given for rejection of the Scheme in the NCLT Order were uncalled for and, and that the NCLT was only required to notice all the requirements of Section 230-232 of Companies Act, 2013.

The NCLAT order also records that the NCLT had noted UFO's and PJSA's submissions that all the procedures prescribed under Sections 230-232 of the Companies Act, 2013, were followed. With the NCLT Order being set aside, UFO believes its position is vindicated and maintains the Scheme was compliant with Sections 230 – 232 of the Companies Act, 2013.
