The Board of Directors has appointed me as the Scrutinizer for conducting the Postal Ballot through Remote E-Voting Process on February 19, 2021 for conducting the E-Voting Process in fair and transparent manner.

Accordingly, I submit my report as under:

- 1. In terms of Sections 108 & 110 of the Companies Act, 2013 ('the Act') read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 ("Rules") and other applicable provisions of the Act and Rules made thereunder, Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the General Circulars No.14/2020 dated 8<sup>th</sup> April 2020, No. 17/2020 dated 13<sup>th</sup> April 2020 and No. 22/2020 dated 15<sup>th</sup> June 2020, No. 33/2020 dated 28<sup>th</sup> September, 2020 and No. 39/2020 dated 31<sup>st</sup> December, 2020, issued by the Ministry of Corporate Affairs, Government of India ("MCA Circulars"), the Company has issued a Postal Ballot Notice dated February 19, 2021 for passing Special Resolutions No. 1 and 2 as mentioned in the said Notice to its Members. As informed to us, the Notice along with the instructions regarding e-voting was being sent only by e-mail to all those Members, whose e-mail address was registered with the Company or with the Depositories/Depository Participants and whose names appear in the Register of Members/list of Beneficial Owners as on the Cut-off Date i.e. February 19, 2021, in accordance with the guidelines prescribed by the MCA Circulars for conducting postal ballot process through e-voting.
- 2. The Company has offered E-voting facility to all its Equity Shareholders who are the Shareholders as on cut-off date i.e. February 19, 2021.
- 3. The E-Voting for Postal Ballot commenced from Thursday, February 25, 2021 at (9.00 a.m. IST) and ended on Friday, March 26, 2021 (5.00 p.m. IST).
- 4. The votes cast by the Shareholders were downloaded after the E-voting Module was disabled by Kfin Technologies Private Limited (hereinafter referred to as 'KFin') and were scrutinized by verifying it using the Scrutinizer's Login on the E-voting website. The votes cast through Evoting were unblocked on March 26, 2021 in the presence of two witnesses, Ms. Khadija Liliyawala and Mr. Abhijeet Ambre who are not in employment of the Company.
- 5. Thereafter, the details containing inter alia, list of Equity Shareholders, who voted "for" or "against", each of the resolution, were generated from e-voting website of KFin i.e. <u>https://evoting.kfintech.com</u> and based on such report generated, the result of the e-voting is given as an **Annexure**.
